He married, in Sacketts Harbor, N. Y., 23 Dec. 1845, ANNA-HENDRICKS BURT, born there, 2 Mar. 1823, died in Ocean Park, Calif., in 1908, daughter of John and Catherine (Hendricks) Burt.

Ellison-Elisha Burton was a wood and lumber dealer, and lived successively in Sacketts Harbor, Manitou Island, Mich., and California.
